Program Fees & Payment Policy

Fees and Payment Dates Overview

Application Fee (\$30) due at time of application submission

- Early Bird (EB) deadline: September 17, 2018
- Regular deadline: October 31, 2018

Non-Refundable Enrollment Fee (\$500) and Room & Board deposit, if applicable (\$500) due 15 calendar days after conditional acceptance is received

- This fee is used to cover all program and administrative costs to enroll an applicant in program and associated activities. It is applied towards full tuition payment.
- If an applicant does not pay the enrollment fee within 15 calendar days of conditional acceptance notification, applicant will lose their spot in program and be required to reapply.

Full Tuition Remaining Balance (EB \$2,500/Reg \$3,000) and Room & Board balance, if applicable (\$2,000) due 30 calendar days before program start date

- If an applicant does not pay the full tuition by the applicable deadline, applicant will lose their spot in program and be required to reapply.

Refund Policy

Tuition

- **Cancellation 30 days or more before program start:** 100% refundable (minus enrollment fee)
- **Cancellation 15-29 days before program start:** 50% refundable (minus enrollment fee)
- **Cancellation 14 days or less before program start:** No refund

Room and Board

- **Cancellation 45 days or more before arrival date:** 100% refundable (minus deposit)
- **Cancellation 44-30 days before arrival date:** 50% refundable (minus deposit)
- **Cancellation less than 30 days before arrival date:** No refund

Financial Assistance Policy

If an applicant is unable to meet the financial requirements and timeline outlined above, the applicant will indicate so when they receive their conditional acceptance and sign their Payment Policy Agreement, due no later than five (5) business days after letter is received. A financial assistance application must be submitted with the Payment Policy Agreement if an applicant will require tuition assistance.

Applicants **MUST** apply for the program and be conditionally accepted before their financial assistance application will be considered. The maximum amount an applicant may receive for tuition assistance is \$250.

Only applicants that apply by the Early Bird deadline (September 17, 2018) will be eligible to apply for tuition assistance, and final decisions will be made by November 1, 2018. Applicants applying after September 17, 2018 will have a payment plan option only.
